SANCTION: This meet is sanctioned by USA Swimming and Indiana Swimming, Inc. Sanction Number IN12303.

HOST CLUB: Boilermaker Aquatics

FACILITIES: Boilermaker Aquatic Center, Purdue University, 355 N. Martin Jischke Drive (formerly Intramural Drive), West Lafayette, IN 47907. It is a 50 Meter 8 lane pool with non-turbulent lane lines; a Daktronics 2000 automatic timing system with touch pads, backup buttons and watches; a continuous warm-up area; and spectator seating in the bleachers. Concessions are available for all sessions. **This is a no smoking facility.** Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. As guests of the university, we would like to remind all participants and spectators to leave a clean facility at the end of the meet.

Parking: Any lot close to the Aquatic Center is free to park after 5 pm on Friday; this includes all A-B-C lots and Residence Hall Lots (these are marked "enforced 24 hours" but ARE OPEN this weekend). There is construction around the Aquatic Center; please check the BA website for parking information.

ELIGIBILITY AND CREDENTIALS Current USA Swimming and Indiana Swimming rules will govern this meet.

USA Swimming Rules 202.3.2 – At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.

“Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer’s legal guardian to ensure compliance with this requirement.”

USA Swimming Rule 104.2.2C(4) – The competition course has not been certified in accordance with 104.2.2.C(4)

USA Swimming Rule 103.2.3 – Minimum water depth for racing starts during competition shall be measured for a distance of 3 feet 3.5 inches to 16 feet 5 inches from the end wall. The depth of this competition pool at the starting end is 9ft and starting platforms shall be used.

Swimmers must be registered with USA Swimming to be accepted into this meet. Age as of May 18, 2012 shall determine the swimmer’s age for the entire meet.

Coaches **MUST** constantly display their USA Swimming Coach Credentials to gain deck access. The meet referee reserves the right to ask for coach credential display and/or deny deck access if coach does not comply.

FORMAT: The BA Early Bird Senior Invitational will be held using the Prelim/Finals format. For the Finals Sessions there will be three heats – Finals, Consoles, and Bonus Consoles.

The exception to the Prelim/Finals format will be the 400, 800, and 1500 Freestyle. These events will be run as timed finals.

The 800 Freestyle will be limited to a minimum of 24 females and the 1500 will be limited to a minimum of 24 males. Those events will be swum fastest to slowest, alternating heats between the women’s 800 Freestyle and men’s 1500 Freestyle. Swimmers must provide their own timers and counters.

Swimmers must meet a **13-14 Age Group A Time Standard** as the minimum qualifying time for all events they are entered. Boilermaker Aquatics reserves the right to enter BA swimmers that do not meet the time standard.

Entry times should be submitted in **LCM** (convert nonconforming times). Events submitted with a custom time that is not LCM will be seeded in the following order: LCM, SCM, SCY.

CHECK-IN: A positive check-in procedure will be used. Swimmers must sign in no later than **45 minutes prior** to the start of each session. Any swimmer not checked-in **45 minutes** prior to the start of the session will be scratched from that session. Once a swimmer has been scratched, they will be allowed to swim only if the event has empty lane(s) available in the first heat. Additional heats will not be added.

Seeded heat sheets, with the scratched swimmers removed, will be printed and given to the coaches of each team.

A positive check-in for the 800 and 1500 Freestyles will end at 10:30am on Sunday. By that deadline the entry time must be verified and the event will be seeded.

ENTRY FORMAT: The following must be submitted by the entry deadline:

- **The entry file by email (zip, cl2 or sd3)**
- **Within 3 business days of receipt of email message, you must mail:**
 - Team summary report and executed release, and hold harmless agreement (included in this packet)
 - Check for payment of all entry fees made out to Boilermaker Aquatics.
- **Times should be submitted in LCM (convert nonconforming times).**

ENTRY LIMITS/ REFUNDS: BA reserves the right to limit entries and events in order to achieve a reasonable time line. In the event the meet is full, teams will be accepted based on competitiveness, geographic diversity, participation in previous meets, officials provided, and timeliness of entries (submitted prior to the entry deadline). Teams will not be broken.

The 800 Freestyle will be limited to a minimum of 24 females and the 1500 Freestyle will be limited to a minimum of 24 males. The events will swim fastest to slowest in alternating heats. Swimmers must provide their own timers and counters.

Each swimmer is limited to **3 individual events per day**. Any swimmer exceeding this limit will be entered in events each day until the limit is met, events thereafter will be dropped. If a swimmer is dropped from a limited event, entry fees for that event will be refunded.

ENTRY DEADLINE: Entries will not be accepted prior to **8:00 am on Friday, April 13, 2012**. Entries must be received by **8:00 pm on Friday, April 27, 2012**. A meet entry report will be sent as confirmation that the entries have been received. If the Meet is not full BA reserves the right to extend the deadline. Teams will be notified on or before May 4, 2011 if they have not been accepted.

Entries received after the deadline will be considered deck entries even if they appear in the psych sheets.

DECK ENTRIES: If in the judgment of the Meet Director, Deck Entries will not overly delay the meet, deck entries will be accepted up until the sign-in sheets are taken down (45 minutes prior to the beginning of the session). The Deck Entries are \$8.00 per Timed final individual entry and \$10.00 per Prelim/Final individual entry, payable immediately.

SCRATCH RULES: After the results of preliminary heats are announced, swimmers have 30 minutes to scratch out of the finals (including consolation and bonus heats). If a swimmer who has not scratched fails to swim in any finals heat, that swimmer will be scratched from his/her first event the following day. This penalty will be imposed as many times as a swimmer misses a non scratched finals event. Fees for scratched events will not be refunded. If a swimmer who has not scratched fails to swim in any finals heat on Sunday evening, the swimmer's team will be assessed a fine of \$50 per event.
